Summary:

On June 28, 2010, Pablo Luis Folonier, Albino Matias Folonier y Sara Ramona Quiroga submitted a complaint expressing social and environmental concerns with regards to the *Multiphase Development Infrastructure: Support Production Entre Rios Project (AR-L1036) (the Project)*, in particular regarding its Energy component. After a detailed review, this Ombudsperson has determined that the complaint is eligible for the Assessment and Consultation Phases under the Mechanism¹.

I. Background

The Project, approved by the Board on November 14, 2007 is located in the City of Parana, Province of Entre Rios of the Republic of Argentina. The complaint raised a series of environmental and social concerns spanning from the lack of due process to expropriate the family lands for the electric station, to the non disclosure of key documentation such as the Environmental Impact Assessment (EIA). This is a Sovereign Guaranteed loan of 104 million dollars financed by IADB.

The complainants had also requested the protection of their property under the Natural Protected Areas Law since they claim, their property neighbors with other four protected areas². More explicitly, they argue that IADB -through the Project- has explicitly violated, among others, the following policies:

- Environment and Safeguards compliance Policy 703
- Sector Policy 733, Energy and the Economic Infrastructure Sectors Sub-policy 733-1 Electric Energy.
- Disclosure of Information, Policy 102

The complainants emphasize the violation of country laws and regulations as it is a requirement in IADB's Policy 703³ for the Project to be in compliance with the national environmental laws and regulations. Regarding disclosure of information, they argue that their right to access to information was violated since every attempt by the Folonier family was blocked by various government agencies, including the Environmental Secretariat of the Province of Entre Rios. The complainants also noted that the IADB's policies, in particular the ones regarding environmental impact assessments have not been observed either by local authorities or by IADB itself. They provide, as an example of this, among others, the lack of screening and classification of the Project.

II. Eligibility Analysis

The Ombuds process starts with the Eligibility Determination to then move to the Assessment phase and finally to the Consultation and mediation Phase, if so agreed by all parties. As part of the Eligibility analysis, an initial dialogue with the Project team is established, and information on the complaint, complainants and the relevant project (s) is gathered. The results of such an analysis are expressed in the table below.

III. Initial consultation with Management

The ICIM's policy calls for an initial consultation with Management to learn what the status of the issue at hand is, confirm that the project team and/or management and/or the relevant country office have been made aware of the complaint, verify the steps taken by the requester to bring this issue to the attention of the Bank, and learn more about the operational response, if any. In this case, the requesters have initially requested confidentiality which they waived through a communication only on October 5, 2010. The complainants have written to this Mechanism confirming its concerns with copy to the Project team. The Project team has been contacted by the Mechanism and is already collaborating with this process.

IV. Conclusion

In line with the ICIM Policy, the Project Ombudsperson has determined that the complaint related to the Multiphase Development Infrastructure: Support Production Entre Rios Project (AR-L1036)- (the Project) is eligible for the Consultation Phase.

The Consultation Phase starts with an Assessment by the Ombudsperson. The purpose of the Assessment is to work with the complainants, management and interested stakeholders to identify -on the ground-and clarify the issues raised by the complainants, gather information on the various points of view and help stakeholders determine whether and how they may be able to find solutions. The Assessment period is limited to a maximum of 120 days, but may be completed more quickly.

Although a complaint may meet ICIM's eligibility criteria, **this does not imply** any judgment on the part of the ICIM of the merit of the issues raised in the complaint.

Within the next two (2) business days, the Executive Secretariat will post the notice of registration on the Registry and notify the Requester.
