RE: Request for Supplemental Information to the Request and determination of the maximum deadline for its submission to the MICI

Dear Sirs,

We have reviewed your Request and the information contained therein, and we have determined that certain information is still needed in order for it to be registered. Therefore, we ask you to provide the following:

According to point II of your claim, we understand that the requesters are the members of the Pitama Reservoir Irrigation Right-holders Association [*Asociación de Canalistas del Embalse Pitama*] and that Mr. Jorge Echaurren Vial is the President of the association.

Please submit some type of documentation to certify his appointment, and contact information for the association as well as information on the number of members.

The claim is signed by Mr. Echaurren on behalf of the Association, but the three following signatures are also included:

1. Agrícola Goyocalán Limitada
2. Agrícola La Foresta, S.A.
3. Ximena Bustos Krumm

Please clarify whether these three parties are also claimants, and if so, please provide the name and contact information of the person signing for each one of the agricultural companies, as well as a certification of representation. The same is required for Ms. Ximena Bustos Krumm.

In the claim, you state that Mr. Echaurren will represent the requesters before the MICI. However, Mr. Echaurren has referred me to Mr. Varela, who in turn referred me to Messrs. Astudillo and Espinosa. We need to establish who will act as the representative and main point of contact with the MICI, and for the representatives of the requesting entities (*Asociación de Canalistas*, *Agrícolas Goyocalán*, and *La Foresta*, as well as Ms. Bustos) to send written confirmation to the MICI of each representative’s name and contact information.

Pursuant to paragraph 20 of the Policy, we are granting you a maximum of **10 business days from the date of this notice** to submit this additional information. Accordingly, the deadline for submission is Monday, **June 13, 2016**. In the event that we do not receive the information by that deadline, the administrative process will be terminated. However, this will not preclude you from refileing your Request once you have the missing information.

Please do not hesitate to contact me should you have any questions regarding the information requested or the MICI process. We invite you to visit our website (www.iadb.org/mici), where you will find information about the process and requirements. I have also attached the MICI Policy to this letter for your reference.
