I. BACKGROUND

- 1.1 On 28 June 2010, the Independent Consultation and Investigation Mechanism (MICI) received a request pertaining to the "Multiphase Program for the Development of Production Support Infrastructure in Entre Ríos." This Request was declared eligible for the Consultation Phase on 8 October 2010, pursuant to the Policy Establishing the Independent Consultation and Investigation Mechanism (document GN-1830-49).
- 1.2 The program objective was to help develop and improve the competitiveness of the economy of the province of Entre Ríos by increasing the available economic infrastructure, ensuring improved serviceability of important sections of the provincial road network, and increasing the capacity and reliability of the electric system. The Program consisted of four subprograms, which were divided into components. Subprogram 1, "Development of economic infrastructure to support production," Component 1.2, "Electricity infrastructure," included the construction of a 500/132 kV transformer station and 132 kV electrical transmission lines in the city of Paraná. The Program's executing agency was the provincial Ministry of the Economy, Treasury, and Finance, through its program execution coordination unit (PCU), and the subexecuting agency responsible for Component 1.2, "Electricity Infrastructure," was Energía Entre Ríos Sociedad Anónima (ENERSA).
- 1.3 The Request was submitted by Pablo Folonier, Matías Folonier, and Sara Ramona Quiroga. Afterwards, a group of residents of the El Brete neighborhood joined the complaint submitted to the MICI. The Requesters cited a series of potential environmental and social impacts stemming from the construction and operation of the transformer station associated with Component 1.2 of the Program. Their concerns included a lack of access to information, environmental risks due to the plant being located near protected areas, and flawed expropriation and environmental license approval processes.
- 1.4 From March 2011 to December 2012, the Requesters, ENERSA, the IDB, and the PCU voluntarily engaged in a dialogue process facilitated by the MICI to address the following issues: (i) options for transformer station technology and design that would represent a significant or appreciable change in terms of visual and/or environmental impacts; and (ii) measures to mitigate visual impacts, implement conservation activities, and promote specific arrangements with relevant public agencies. As a result of that process, the Parties signed a "Memorandum of Understanding and Commitment" in December 2012.
- On 17 December 2014, the IDB Board of Executive Directors approved the new MICI Policy. With a view to clarify the procedures for managing cases initiated under the previous policy, the Board of Executive Directors approved a Transition Plan on 4 February 2015. Pursuant to that Plan, the time limit for monitoring Case AR-MICI001-2010 would be five years from the date the new MICI Policy was approved. Furthermore, the MICI would submit an annual Monitoring Report to the Board of Executive Directors for information.
- 1.6 Background information and the public documentation prepared during the MICI process is available for consultation in the case file for Case AR-MICI001-2010 in

the MICI's Public Registry.¹ This information includes all Monitoring Reports drafted by the MICI prior to the release of this Case Closure.

II. CONSULTATION PHASE REPORT AND AGREEMENTS REACHED

- 2.1 The Memorandum that resulted from the dialogue facilitated by MICI included agreements on the following issues: (i) measures for mitigating the visual impact of the transformer station and high voltage lines (ii) improvements in the infrastructure conditions of the El Brete neighborhood; (iii) the creation of a private natural protected area; (iv) the implementation of a Citizen Participation Plan; (v) lawsuits associated with the process; (vi) communication with the press.
- 2.2 The Parties agreed to the following activities to fulfill the commitments undertaken:

2.3 That memorandum represents the coordination of actions by a variety of stakeholders, including the Requesters, ENERSA, the IDB, the PCU, the Municipality of Paraná, the Provincial Highway Authority, and the Ministry of Health of Entre Ríos Province.

III. MONITORING THE AGREEMENTS

- 3.1 During monitoring, the MICI remained in contact with the Parties to monitor the progress made in fulfilling the commitments assumed. A facilitation team hired by ENERSA reported that the Citizen Participation Committee held approximately 35 meetings to address the issues raised in the Request. The MICI participated in these meetings via videoconferencing, and it also conducted four missions to Entre Ríos between 2013 and 2018 to monitor the agreements. Monitoring reports that provide an account of the progress made were published annually and can be consulted through the Public Registry.
- 3.2 From December 2012 to September 2016, progress was made in fulfilling many of the agreements. Notably, measures for mitigating the visual impact of the transformer station were implemented, three-phase power service connections for the residents of the El Brete neighborhood were installed, and road safety measures and the Citizen Participation Plan were implemented.
- 3.3 However, as of mid-2016, no progress had been made in the construction of the health center, which was included in the terms of the Memorandum as a compensatory work, because action in that regard fell outside the scope of the parties' decision-making authority.
- 3.4 Therefore, the parties searched for alternative compensatory works. They agreed to improve the road network in the El Brete neighborhood, and together they identified the areas where this intervention would take place and the works it would entail. During this process, site visits were conducted in the neighborhood with staff from the PCU and the Provincial Highway Authority, which was responsible for drafting the technical proposals for the works.
- 3.5 On 28 May 2018, representatives from the Requesters, the IDB, the PCU, and ENERSA reached a final agreement on the measures proposed by the Provincial Highway Authority, which are recorded in File Nº 2085643. In accordance with the arrangements made by the parties, the improvement works would cover Fraternidad, Tarnowsky, and Jorge Luis Borges streets in the city of Paraná. ENERSA, in conjunction with the Provincial Highway Authority, has drafted technical documentation based on that agreement for the competitive process to select a contractor and proceed to execute the additional works. As of the completion of those works, the agreements made during the MICI Process are fully fulfilled.
- On 25 September 2018, the MICI conducted a verification mission to the city of Paraná, where the parties confirmed that progress was being made in executing the works. To date, the bidding process has been finalized, and the contract is in the process of being awarded to the selected company so that the execution of the agreed works can begin. As part of the closure mission, the parties signed the "Official Notice of Case Closure," which is included as an annex to this report.

IV. CASE CLOSURE BY THE MICI

- 4.1 The Guidelines for the Consultation Phase (MI-74) facilitate the systematic application of Section H of the MICI Policy, providing a road map for case management in the Consultation Phase. Section VII of those Guidelines dictates the reasons for ending the Consultation Phase, which include: (a) when the Parties have reached an agreement including a monitoring plan, and compliance with those obligations has been verified with the agreement of the Parties (paragraph 7.3); and (b) when the MICI Director believes that the MICI's participation does not provide added value during the Monitoring Stage and finalizes the processing of the case (paragraph 7.7).
- 4.2 In consideration of the foregoing, and having verified the fulfillment of the commitments assumed by the Parties during the MICI Consultation Phase, MICI submits this Case Closure to the IDB Board of Executive Directors, finalizing the processing of Case AR-MICI001-2010 and underscoring the results of this process, which include: the installation of three-phase electric power in homes; increased road safety; upgrades to neighborhood infrastructure; and improvements to access points, which results in better conditions for water runoff and reduces the risk of flooding in El Brete.
- 4.3 The MICI thanks the Parties for their collaboration and constructive participation throughout the process, and it notifies them and the general public of the closure of this process.
